### **Studio Policies** - Please initial the following items stating that you have read, understand and agree

\_\_\_\_\_ (1) Sound Beginnings consists of 6 non-sequential semesters, as well as 3 summer sessions. Registration for Sound Beginnings is for one semester or session at a time and will need to be completed for each semester that you wish to participate in.

\_\_\_\_\_ (2) A parent/caregiver must attend class with the child.

\_\_\_\_\_ (3) Only children enrolled in the program may attend classes. Please arrange for a babysitter for older siblings. Children may not be left in the home unattended.

\_\_\_\_\_ (4) Please leave toys, snacks, or anything that may be a distraction to other children, at home or in your bag. No food, gum or drink is allowed in class.

\_\_\_\_\_ (5) Please inform the teacher if you will be missing class. Please do not bring your child to class if they have had a fever, diarrhea or vomiting within 24 hours of class.

\_\_\_\_\_ (6) Classes are 30 minutes long. Class begins and ends on time. Arriving 5 minutes early allows you and your child time to get settled in class and feel unrushed and relaxed. Arriving on time ensures your child will participate in every minute of learning time.

\_\_\_\_\_ (7) When you sing and play along with your child in class and at home, you are modeling and reinforcing what we want the child to do, maximizing your investment in your child's development. Children learn best when they feel loved. Please participate with us in class: stand, dance, sing, and play!

\_\_\_\_\_ (8) Please help all of the children in the studio and the neighborhood be safe by driving safely to and from class. Always check behind your vehicle before backing out. You may park in the driveway, or on the rocks to the north of the house. Do not park in the street or in front of any neighboring homes. Please do not go into the side or back yards before, during or after class.

## **Trimble Music Studio, LLC - Fee Schedule for the Sound Beginnings Program**

### **Registration Fee:**

- \$15 per family per semester

### **Tuition Schedule (per semester):**

- A parent/caregiver with a single child: \$180
- A parent/caregiver with more than one child in the same nuclear family: \$220

Tuition is due on the first day of class. If needed, you may arrange to pay the tuition with automatic installments. There are 15 lessons in each semester (8 lessons for summer sessions). Tuition is not discounted, prorated or refunded due to missed lessons.

### **Student Materials:**

The cost of student materials is set by Let's Play Music and is subject to change. It currently ranges from \$21-35 per semester. This is paid directly to Let's Play Music when you enroll for each semester. A Sound Beginnings tote bag is an important tool for class. It only ever needs to be purchased once per family. The cost of the tote bag is currently \$8.

### **Liability Waiver**

The Let's Play Music program involves physical movement and activity. Accidents can happen and there is a risk of injury. By registering in the program, the parent or legal guardian accepts full financial responsibility for any accident or injury that could possibly happen to their child, themselves, or any guest accompanying them while at Trimble Music Studio. You agree to assume the risk of any and all injury to your child, yourself, or anyone else you bring or invite to the property. You agree to release, hold harmless, and indemnify Let's Play Music, Trimble Music Studio, LLC, the current property owners, Jennifer and Randy Trimble with their family members and heirs, from any and all claims, losses, damages, liabilities, penalties, expenses, legal fees and costs of any kind or amount whatsoever, which result from your child's participation in the Let's Play Music program with Trimble Music Studio, LLC.
